### IMPORTANT SAFEGUARDS

For your protection, please read these safety instructions completely before operating the appliance, and keep this manual for future reference

Carefully observe all warnings, precautions and instructions on the appliance and described in the operating instructions supplied with the appliance.



Water and Moisture - Do not install the appliance near water: for example, near a bathtub, washbowl, kitchen sink, laundry tub, in a wet basement, or near a swimming pool.

Grounding or Polarization - Do not defeat the grounding or polarization feature of the AC power cord. If your AC receptacle will not accept the power cord plug, contact your electrician to install a proper AC receptacle.

When not in use - Unplug the power cord of the appliance from the outlet when left unused for a long period of time. To disconnect the cord, pull it out by grasping the plug. Never pull the plug out by the cord.

# **CONTROLS AND CONNECTORS**

#### DC POWER INLET

Accepts any standard 9VDC power supply.

#### BASS CONTROL.

Regulates the amount of bass frequencies.

#### **GAIN CONTROL**

Controls the amount of boost.

#### LED

Indicates Crusher is engaged.

#### **OUTPUT**

The output is designed for running instrument cables directly to your amplifier.

#### MID CONTROL

Regulates the amount of midrange frequencies.

#### TREBLE CONTROL

Regulates the amount of treble frequencies.

#### **VOLUME CONTROL**

Regulates the amount of output.

#### INPUT

Plug in your guitar, bass or the previous instrument level output of your signal chain.

Engages the Crusher effect.


# **BATTERY REPLACEMENT**

#### BATTERY COMPARTMENT

Pull the latch to the left with thumbnail to release the hinged battery compartment cover. Carefully unplug battery without straining cables. Replace with fresh battery in reverse order.

Use a standard 9Volt battery. Battery life is about 300 hours.

Unplugging the input to the Crusher will turn the unit off and conserve battery life.




# POWER SUPPLY CONNECTOR

# **APPLICATIONS**

We recommend placing the Crusher before your amplifier or after any overdrive/distortion pedal for the most desirable effect, but please feel free to experiment

Please Note: When using a BBE Sonic Stomp we recommend placing it last in the signal chain.

# **MAINTENANCE**

Maintenance of the BBE Crusher is limited to proper cleaning of the unit with mild household cleaner such as Formula 409<sup>TM</sup> or Windex<sup>TM</sup>.

There are no user replaceable parts and the unit should not be opened for any reason unless you are a qualified technician. Calibration should be performed if parts are replaced or if a performance check-out indicates a problem with calibration. Long term use has shown that over the life of this unit there is little or no drift of the components in the BBE Crusher which would cause a change in calibration.

### WARRANTY

Warranty registration of the unit to BBE Sound, Inc. is not necessary. It is strongly recommended that you retain a copy of the bill of sale for future reference.

IT IS THE SOLE RESPONSIBILITY OF THE END USER TO PROVIDE THE BILL OF SALE OR OTHER MEANS OF PROOF OF PUR-CHASE TO VALIDATE THE WARRANTY IF WARRANTY SERVICE IS REOUESTED.

The BBE Crusher is warranted against defects in material and workmanship for a period of five (5) years from date of purchase from BBE Sound Inc. or from an authorized dealer. During this period, we will repair units free of charge providing that they are shipped prepaid to:

We will pay return UPS shipping charges within the USA. All charges related to non-UPS shipping, including customs clearance, will be billed. The warranty will be honored for the longer of either 90 days from the date of any service or the remainder of the original 5 Year factory warranty.

This warranty will be consider null and void by BBE Sound, Inc. if any of the following is found:

- 1. The equipment has been physically damaged.
- 2. The equipment shows signs of abuse.
- The equipment has been electrically damaged by improper connection or attempted repair by the customer or a third party.
- The equipment has been modified without authorization.
- The bill of sales indicates that the purchase date of the equipment is not within the warranty period.

All non-warranty repairs are warranted for a period of 90 days from the date of service.

BBE Sound, Inc. is NOT LIABLE FOR CONSE-QUENTIAL DAMAGES. Should the unit fail to operate for any reason, our sole obligation is to repair it as described above.
